"Women's rights are human rights" is a phrase used in the feminist movement. The phrase was first used in the 1980s and early 1990s. Its most prominent usage is as the name of a speech given by Hillary Rodham Clinton, the First Lady of the United States, on 5 September 1995, at the United Nations Fourth World Conference on Women in Beijing. In this speech she sought to closely link the notion of women's rights with that of human rights.
