Financial Counseling Association of America. If you come into any money while the bankruptcy order is still in place, this could also be taken away - if you win the lottery, for example. You could also find yourself credit blacklisted for up to 15 years, under a draconian new bankruptcy restitution order. Who it suits. You could write to your creditors and make an informal arrangement to pay back your debts over a specific time agreed by them. The only disadvantage is that it won't be legally binding and your creditor might choose to ignore it later on. If your debts are fairly small (i.e. under £5,000) and you have a regular income the court may agree to set up an administration order whereby you pay your creditors each month but through the court. There are no fees for this - but the court will take a small percentage towards its costs.
